

Da Vinci Residency/Fellowship Training Certificate of Training Equivalency Requirements and Letter

Da Vinci Platforms

Background

A growing number of surgical residency and fellowship programs now include the use of the da Vinci system as part of their curriculum. A resident or fellow who completes such a program and goes on to seek employment at a hiring hospital may find that the hiring hospital is interested in learning more about the resident's/fellow's da Vinci system experience. To help residents/fellows communicate this information, Intuitive has established a Certificate of Training Equivalency for qualifying residents and fellows.

The Certificate of Training Equivalency is not a replacement for any hospital's credentialing requirements and is not a representation of clinical competence, as Intuitive only trains on the use of the da Vinci system.

In order to qualify for a Certificate of Training Equivalency, a resident or fellow must satisfy all of the criteria listed below. Completion of each activity should be documented in a da Vinci Skills Tracker for Residents & Fellows worksheet (PN1024649). Upon completion of the activities below, the online assessment certificate, case log (recommended), and letter from program director or chief of surgery should be submitted to Intuitive for Certificate of Training Equivalency consideration.

In order to qualify for a Certificate of Training Equivalency, residents and fellows must complete all of the requirements listed:

Certificate of Training Equivalency Requirements

1. Technology Learning Plan and Assessment (Completed online in Intuitive Learning)

Online introduction to the da Vinci technology which covers topics such as:

- The basics of surgical energy use
- Da Vinci surgical system overview
- Da Vinci surgical system pre-operative use
- Da Vinci surgical system intra-operative use

- Da Vinci surgical system post-operative use
- Endoscope Plus training guide
- Da Vinci Handheld Camera training guide
- ConMed reference guide

2. Da Vinci Technology Inservice

Hands-on introduction to the da Vinci system which covers topics such as:

- Port placement
- Patient Cart setup
- Docking and undocking
- Instrument insertion and exchange
- Surgeon Console settings

- Camera control
- Clutching
- EndoWrist® instrument manipulation
- 3rd arm control
- Range of motion

- Retraction
- Dissection
- Suturing
- Applying energy
- Troubleshooting
- Communication



Certificate of Training Equivalency Requirements Continued

3. Da Vinci Online Assessment

4. Documentation

- Learning plan assessment certificate
- Letter from the chief of surgery or equivalent verifying da Vinci technology training and the procedures in which the surgeon participated
- Case Log (optional). Performance of procedures using the da Vinci system in primary role of console surgeon

Once completion of the above requirements has been confirmed, a Certificate of Training Equivalency will be issued.
